#### 6 Cancellation rights

We will send you a cancellation notice and you will have 30 days from receipt of this notice to notify us that you have changed your mind and wish to cancel your application.

#### For applicants who have appointed a Financial Adviser

We will proceed with your Modular GIA application during your 30 day cancellation period and you can give us investment instructions during this period. However, if you choose to cancel your Modular GIA under the terms of the cancellation rights, any investment held by your Modular GIA will be sold and we will return any contributions that were made into your Modular GIA to their original source. The amount to be repaid may be less than the amount paid to us if the value of your investment has fallen at the time it is sold. This will be explained in the cancellation notice that we will send you.

#### For applicants who do not have a Financial Adviser

As you have not received any advice from a Financial Adviser before applying for your Modular GIA you will receive a 30 day period during which you can cancel your Modular GIA application. During this period we will not permit any investments within your Modular GIA in case you decide to cancel.

However, you have the option to waive your rights to your 30 day cancellation period. If you choose to do this, we will proceed with your application and any money held within your Modular GIA will be available for immediate investment upon receipt of your instructions.
